UNOPPOSED ORDER GRANTING MOTION FOR APPROVAL OF INTERIM FEES
AND EXPENSES

This matter came before the Court without a hearing on the Assignee Nir Gavra's (the "Assignee") Motion for Approval of Interim Fees and Expenses incurred by the Assignee and the Assignee's Professionals (the "Motion") (Doc. 32). The Motion seeks an award of interim compensation for the Assignee, the Assignee's counsel Hoffman, Larin & Agnetti, P.A. ("HLA') and the Assignee's financial advisor Development Specialists, Inc. - B. No party objected to the Motion within the time permitted; and
- C. The Court therefore considers this Motion to be unopposed and the relief requested may be granted without a hearing pursuant to F.S. 727.111(4).

Accordingly, it is ordered as follows:

- 1. The Motion is granted.
- 2. The Assignee is awarded interim fees of \$14,490.
- 3. HLA is awarded interim fees of \$27,456 and interim costs of \$1,982.46.
- 4. DSI is awarded interim fees of \$6,858.
- 5. The Assignee is authorized to pay and distribute these approved amounts.
- 6. The Court reserves jurisdiction to enter all further orders that may be necessary or appropriate.
