ORDER SUSTAINING AMENDED OBJECTION TO CLAIMS OF BSD NORTH DIXIE, LLC CLAIMANTS

This matter came before the Court on the Assignee's Amended Objection to Claims of BSD North Dixie Claimants (the "Claim Objection") (Doc. 62) which included a Notice of Opportunity to Object and Request a Hearing. On March 5, 2025, the Court entered an Order Granting Motion to Set Notice Procedures for Claim Objections (the "Service Order") (Doc. 70), which permitted the Assignee's Israeli counsel E. Landau to serve copies of claim objections on claimants with Israeli addresses through the Israeli postal system. On May 8, 2025, the Assignee filed the Supplemental Declaration of Meir Heller (the "Heller Declaration") (Doc. 75), which reflects service on all claimants listed in the Claim Objection in accordance with the Service Order. No claimant has filed a response to or requested a hearing on the Claim Objection, and the 21-day negative notice period has expired. Accordingly, pursuant to Fla. Stat. s. 727.113(1), the Court presumes that there is no opposition to the granting of the relief requested in the Claim Objection and the Assignee may obtain the entry of this Order without further notice or hearing. It is therefore **ORDERED**:

1. The Claim Objection is sustained.
