- 2. The Assignee's Final Report, a copy of which is attached to the Motion, is approved and the Assignee is authorized to distribute the assets of the estate in accordance therewith.
- 3. The fees and costs of the Assignee and his professionals are approved. The Assignee is authorized to pay:

- b. Lessne Hoffman, PLLC \$34,977.50 in fees and \$14.15 in expenses for a total of \$34,991.65.
- c. The law firm of E. Landau \$32,150.00 in fees and \$1,353.85 in expenses for a total of \$33,503.85.
- d. Your Tax Consultants Financial Advisory \$15,000 in fees.
- e. The Assignee \$23,700.00 in hourly fees and \$237,554.93 in receipts-based compensation for a total of \$261,254.93.
- 4. The Court finds that the time expended, hourly rates charged, and total compensation requested by the Assignee and his professionals are reasonable and appropriate under the circumstances of this case. All interim fee awards previously approved are hereby approved on a final basis.
- 5. The employment of Your Tax Consultants Financial Advisory as the Assignee's accountant is approved *nunc pro tunc* to the commencement of his services for the estate.
- 6. The Assignee and all professionals retained in this case are hereby discharged and released from any further duties, obligations, or liabilities incurred in connection with this proceeding.

 Any remaining non-cash assets of the estate are abandoned to the Assignor.
- 7. The Assignee's bond is released.
- 8. This case is hereby closed.
